## 1. Transfer of Ownership:

- The undersigned current owner (hereinafter referred to as "Transferor") hereby irrevocably transfers and assigns all rights, ownership, and associated responsibilities for the dog described in this agreement (hereinafter referred to as "the Dog") to the designated new owner (hereinafter referred to as "Transferee"), effective as of the date specified in this agreement.

## 2. Health and Veterinary Care:

- The Transferor affirms that, to the best of their knowledge, the Dog is in good health at the time of transfer. However, no guarantees regarding the Dog's future health are provided. The Transferee acknowledges and agrees to assume full and exclusive responsibility for the Dog's health care needs, including but not limited to, routine and emergency veterinary care, vaccinations, and any other medical treatments required from the date of transfer.

## 3. Care and Welfare:

- The Transferee commits to providing the Dog with a high standard of care, including, but not limited to, adequate food, fresh water, suitable shelter, and necessary medical care. The Transferee agrees to ensure that the Dog is treated humanely at all times, with respect and consideration for its well-being.

## 4. No Liability:

- The Transferor shall not be held liable for any injuries, damages, or losses that may occur after the date of this transfer, which may be caused by or related to the Dog. The Transferee assumes all risks and responsibilities associated with the Dog following the effective date of transfer.

## 5. Return Policy:

- There is no return policy for the Dog under this agreement. Should the Transferee be unable to care for the Dog, it is the Transferee's responsibility to make suitable arrangements for the Dog's future care, which may include contacting an appropriate animal shelter or rescue organization.
