SPECIAL BALLOT POINTS

- If you are NOT of the Permanent Electors Register, you will need to submit a copy of acceptable ID twice. The first time with your Form 13 (Elector Register) and a second time when you return your completed ballots. You can register to vote at https://www.elections.ab.ca/voters/register-to-vote prior to requesting your Special Ballot Package.
- 2. The Certification Envelope Form, which is part of the ballot package, must be witnessed by someone who is an eligible elector.
- 3. When requesting the Special Ballot package you must ask for each type of ballot you wish to cast ie. Mayor, Councillor, School Board Trustee (specify which school board you support).
- 4. Any ballots sent out prior to September 26, 2025 will be "Write In Ballots". You must write the name of candidate(s) of your choice on the ballot. You can find a list of accepted nominations, to date, at https://rockymtnhouse.com/p/elections.
- 5. Once the ballot(s) have been mailed out you will be recorded as "Voted" which means you cannot receive another ballot.
- It is your responsibility to ensure that the completed ballot package is received at the Town of Rocky Mountain House office (5116 – 50th Ave, Rocky Mountain House no later than 16:30 October 17, 2025.
